

**LHF VOLUNTEER
WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT**

The undersigned (“**Volunteer**”) agrees to be a volunteer for the Lutheran Heritage Foundation (“**Foundation**”) and to travel overseas to certain destinations agreed to between Volunteer and Foundation for purposes of furthering the Foundation’s charitable purposes that include (i) teaching and encouraging worship and Bible study that is faithful to the heritage of the Scriptures and Lutheran Confessions; and (ii) to translate, publish, distribute and introduce to the Christian and non-Christian communities world wide materials which are faithful to the heritage of the Bible and the Lutheran Confessions.

Volunteer understands that traveling to any destination poses various inherent risks and dangers and many of the seminaries and destinations to which the Foundation sends its volunteers are located in underdeveloped and sometimes dangerous areas of the world. Accordingly, Volunteer fully realizes that the conditions in the destinations to which the Volunteer will travel for the Foundation are not of the same standard to which the Volunteer is accustomed (i.e. political environment, judicial system, available health care and the like). Volunteer further realizes that travel to such destinations poses various health and detainment risks, as well as other risks that may result in death, to Volunteer and the Volunteer’s personal property, which risks may be caused by, among other things, hazardous traffic, poorly constructed roads, dangers resulting from military and/or political unrest, theft, sickness and disease.

By execution of this Agreement, Volunteer hereby fully and completely waives all possible claims against the Foundation and the Foundation’s directors, officers, employees, agents and representatives (collectively “**LHF’s Agents**”) for personal injury, negligence or other legal theory of recovery whatsoever, occurring or accruing in connection with any injury, including death, or property damage incurred or sustained by Volunteer and arising out of Volunteer’s participation as a volunteer for the Foundation and Volunteer releases the Foundation and LHF’s Agents from any and all liabilities and obligations relating to such claims. The foregoing waiver and release of claims shall be binding upon and fully enforceable against the Volunteer and Volunteer’s agents, heirs, personal representatives and other legal representatives (collectively “**Volunteer’s Agents**”). In the event Volunteer or Volunteer’s Agents make any such claims against the Foundation and/or LHF’s Agents in breach of this Agreement, Volunteer or Volunteer’s Agents, as applicable, shall pay all reasonable attorney fees and costs incurred by the Foundation and LHF’s Agents, as applicable, incurred in connection with defending any such claims and/or in the enforcement of the terms of this Agreement.

Volunteer further agrees to indemnify, defend and hold the Foundation and LHF’s Agents harmless from and against any and all claims, actions, suits, proceedings, costs, expenses, damages and liabilities, including reasonable attorney fees, arising out of, connected with, or resulting from Volunteer’s participation as a volunteer for the Foundation, whether caused by Volunteer’s actions, omissions or negligence.
